## OUR SERVICES

**Domestic Violence and Dating Abuse:** Experienced advocates from *Jersey Battered Women's Service* provide emotional support, safety planning, and access to community resources. Advocates can also provide access to the agency's safe house and batterers' counseling program.

**Children's Services:** Individual & group support for children of abusive homes.

**Legal Assistance:** Provided by attorneys from *Legal Services of Northwest Jersey*, *Morris County Organization for Hispanic Affairs*, and the *Morris County Bar Foundation*, legal assistance is offered with restraining orders, family matters, housing, immigration, and more.

*Morris County Prosecutor's Office* investigates/prosecutes the offender and provides criminal prosecution status updates. *Morristown Police Department* assists with criminal investigations and filing for restraining orders.

**Culturally Specific Services:** Advocacy for South Asian survivors is provided through *Manavi*. Advocacy for Spanish speaking survivors is provided through most partner agencies directly and *Morris County Organization for Hispanic Affairs*.

**Sexual Abuse:** Counseling, advocacy, respect, education and support for sexual assault survivors, their families and their partners are provided through *Morris CARES*.

**Human Trafficking:** Support services, advocacy, & safety planning for survivors.

## ABOUT DOMESTIC VIOLENCE AND DATING ABUSE

Intimate partner abuse includes verbal, emotional, economic, physical, and sexual abuse, as well as intimidation and threats.

Dating and domestic abuse are very common and affect people regardless of age, gender identity, race, socioeconomic status, ethnicity, or religion. A person may be a victim even if he/she is not legally married to the abusive partner, is gay, lesbian, or transgender, separated or divorced, or is abused by someone else in the household, such as a parent, sibling or child.

Children who witness domestic violence are at risk of being physically harmed themselves and of suffering from emotional trauma and stress induced health problems.

## ABOUT SEXUAL ABUSE

It is never okay to engage in sexual activity without someone's consent, even when dating or married. Sexual assault in a relationship rarely exists in a vacuum. It often occurs alongside other forms of abusive behavior. Talking with a professional in a safe, confidential environment is the first step to recovery.

## ABOUT HUMAN TRAFFICKING

Human trafficking shares similarities with domestic and sexual abuse. Abusers and traffickers use power and control to dominate their victims who are usually women. Common tactics used by traffickers include isolation, physical and emotional violence, sexual abuse and exploitation, financial abuse, threats to family members, use of children to manipulate and control their victims, withholding of food, sleep, and medical care, among others.
